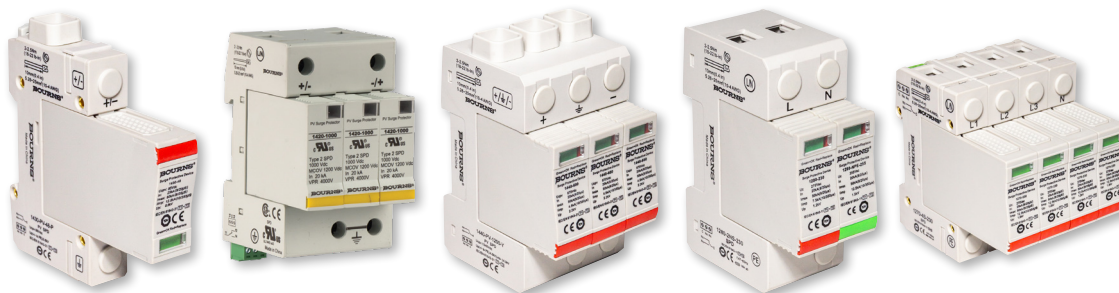

Changes to Inner Packaging

Riverside, California – December 17, 2024 – As part of our continuous improvement and waste reduction efforts, effective April 1, 2025, Bourns will change the packaging for the Model [1250A](#), [1260](#), [1270](#), [1280](#), [1420A](#), [1430](#), and [1440](#) Series Surge Protective Devices. A list of affected part numbers is shown below.

To meet the EU Plastic Tax Regulation, we will eliminate the plastic bag which is used to hold the remote signal terminal of the SPD. Consequently, we will change the inner packaging structure with a notch to fit and protect the remote signal terminal. The packaging size will be changed accordingly.
