Description Of Change

ADI is transferring to qualified subcontructor Amkor Philippines for the assembly of 12x12 TQFP_EP Pre-Plated Frame (PPF) products. ADI will be qualifying Amkor's standard bill of materials(BOM). The die attach epoxy will change from 8361J to CRM1076YB, and the mold compound material will change from GE7470LQ to Sumitomo G631HQ. The package outline dimensions and wire sizes of each product will be maintained.

Reason For Change

ADI is transferring to Amkor Philippines due to the closure of the Amkor Korea factory in October of 2015.

ADI's assembly subcontractors manufacture products using Analog Devices specified manufacturing flows, materials, process controls and monitors, ensuring the same level of quality and reliability.

Impact of the change (positive or negative) on fit, form, function & reliability

The transfer will have no impact on the form, fit, function and reliability of the devices.

The parts that will be assembled after BOM change will be identified by assembly lot number and the country of origin.
