Dimensional drawing of new EPS tray

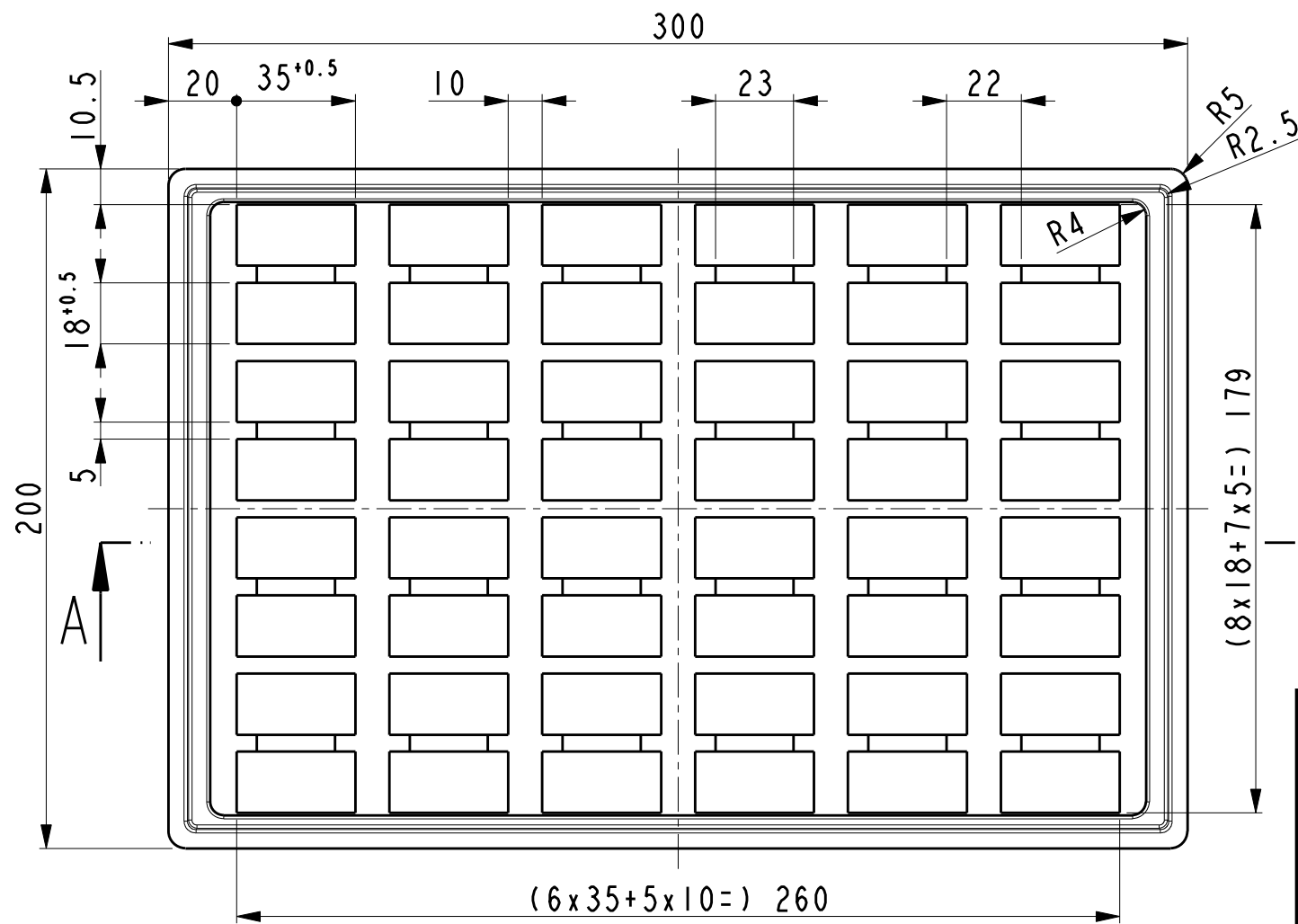
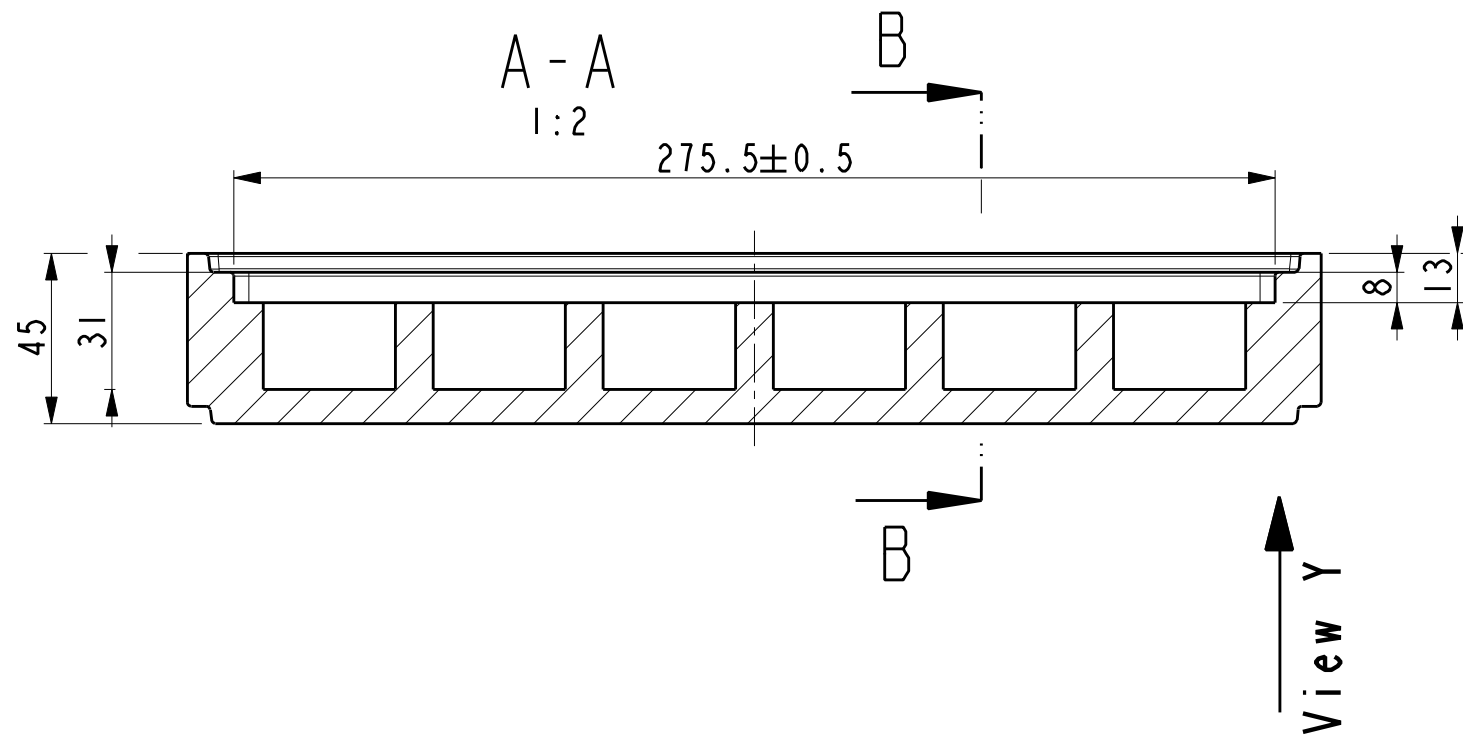
